## Steps to becoming a CPA

- 1 Graduate high school

- 2 Earn a university degree
  - ✓ Major in **accounting** for your undergraduate studies
  - or
  - ✓ Earn an **undergraduate degree** in another discipline
  - +
  - ✓ Take **prerequisite courses** (via CPA preparatory courses or post-secondary institution)

---

- 3 Complete the CPA Program
  - ✓ Complete the **CPA Professional Education Program** (approximately 24 months)
  - ✓ Write and pass the **Common Final Examination**
  - ✓ Obtain **practical work experience** while completing the education program (approximately 30 months in total)

Act ethically and demonstrate professional values
