2. The Student hereby consents to CPABC and its successors, or third parties or others working for or on its behalf, including service providers, officers, directors, agents, and any publishers, advertising agencies, promotional agencies or other media, collecting, storing, using and disclosing the personal information of the Student submitted for the purpose of registering with CPABC and its administering competitions, conferences and/or seminars. Personal information is collected under the authority of the *Freedom of Information and Protection of Privacy Act* [RSBC 1996]. 3. Subject to Section 4, below, the Student hereby gives permission to CPABC and its successors, or third parties or others working for or on its behalf, including service providers, officers, directors, agents, and any publishers, advertising agencies, or other media to reproduce, copy, publish, or otherwise use his or her likeness and name in video, internet, printed literature and print ads, and to reproduce, copy, publish, or otherwise use his or her likeness and interview content, as is or as may be reasonably retouched or edited, as taken from a photograph, videotape or any material based upon or derived therefrom. The Student acknowledges and agrees that this information may be reproduced, used, distributed, or stored inside or outside of Canada.

4. CPABC agrees that the use for which permission is given is limited to recruitment and related purposes, and that it will make no other use of the Student's image and related material without prior written permission of the Student.

5. The Student agrees that CPABC has the right, in its sole discretion, to require proof of identity and/or eligibility from the Student prior to accepting the registration. Provided that CPABC complies with all of its obligations as set out above, the Student agrees to release, indemnify, and hold harmless CPABC and its successors, its members, service providers, officers, directors, and agents, from any claims, damages, injuries, costs, or actions, including without being limited to, any claim based on invasion of privacy, defamation, breach of intellectual property rights, or right of publicity incurred or arising as a result of this agreement or the Student's breach of any term of this agreement.
