# Sample Support Letters for CPA Yukon Fellowship Nominations

## Supporting Letters

Thank you for taking the time to nominate a deserving CPA Yukon member for Fellowship.

The samples provided portray the “ultimate” candidate and are meant to help you understand what kind of details are required in the supporting documentation for a thorough package, which is a vital component of a successful nomination. When completing the nomination form, include distinctive and unique information focusing on specific contributions, impact and leadership of the individual being nominated rather than generalities.

**The number of letters is not important; the quality of the endorsements is crucial.** The letters of support should clearly show the nominee's leadership and what makes their performance stand out (i.e. the exceptional nature of their performance). Nominators are encouraged to collect letters covering the different areas of achievement (exceptional service to the profession, extraordinary career achievements, and/or exemplary contributions to the community).

Ideally, the letters would include the following:

1. A brief description of the organization, its work, and role in the community or the profession.
2. The details of the nominee's involvement with the organization, including:
  - o The role the nominee held and length of service;
  - o Significant accomplishments during the nominee's tenure;
  - o The actions or duties the nominee took to achieve the accomplishment;
  - o The time commitment (if applicable); and
  - o The impact of the nominee's work on the organization and/or its members.

## Other Support Materials

Any emails, links to media clippings, or publications or excerpts can also be submitted as supplementary backup. These items can reflect the same details as above or complement the factual information provided.
