- The Ambassador agrees and acknowledges that the Ambassador has no claim for any compensation or benefit from CPA British Columbia or any party acting on its behalf, arising from this agreement.
- Provided CPA British Columbia complies with all of its obligations, set out above, the Ambassador agrees to release, indemnify, and hold harmless CPA British Columbia and its successors, its members, officers, directors, and agents, from any claims, damages, injuries, costs, or actions, including without being limited to, any claim based on invasion of privacy, defamation, breach of intellectual property rights, or right of publicity incurred or arising as a result of this agreement or the Ambassador's breach of any term of this agreement.
